The Details:

THE ORGANIZATION WILL USE AN ORDER FORM PROVIDED BY JB'S BARNYARD TO COLLECT ORDERS FOR PINTS OF ICE CREAM.

ORDER FORMS WILL BE PROVIDED BY JB'S BARNYARD RIGHT BEFORE YOUR ORGANIZATION STARTS FUNDRAISING. OUR PINT FLAVOR AVAILABILITY CHANGES THROUGHOUT THE YEAR.

PINTS ARE SOLD TO YOUR CUSTOMERS FOR \$8.00 EACH. THE ORGANIZATION WILL RECEIVE A DONATION FROM JB'S BARNYARD FOR 25% (\$2.00 PER PINT) OF THE TOTAL SALES MADE.

THE ORGANIZATION LEAD WILL COLLECT ALL OF THE ORDER FORMS ONCE ALL OF THE PARTICIPANTS ARE FINISHED FUNDRAISING. THE ORGANIZATION LEAD WILL SUBMIT ONE ORDER FORM TO JB'S BARNYARD VIA EMAIL THAT WILL SHOW THE ENTIRE ORGANIZATION'S TOTALS PER FLAVOR.

PLEASE GIVE JB'S AT LEAST 2 WEEKS TO PREPARE THE ORDER.

ONCE YOUR ORDER IS SUBMITTED, JB'S BARNYARD WILL NEED TO COLLECT THE FULL PAYMENT OF \$8.00 PER PINT SOLD FROM THE ORGANIZATION BEFORE WE BEGIN PREPARING YOUR ORDER. AT THE TIME OF DELIVERY, JB'S BARNYARD WILL BRING A CHECK WITH THE DONATION BACK TO YOUR ORGANIZATION.
